



# ASSOCIATE MEMBER APPLICATION

The Associate Member positions within the Mission Hills Business Improvement District (BID) were established through the bylaws of the BID to encourage businesses and individuals who are interested in supporting the Mission Hills business community through the BID and its activities. Associate Members may qualify as either **voting** or **non-voting** members.

All applications for Associate Members, or their Delegates to the BID, shall be on the **Associate Member Application** form. Such applications shall be subject to approval of the Board of Directors. Each Member shall pay annual dues in such amounts as determined from time to time by the Board of Directors. **For FY19 (July 1, 2018 – June 30, 2019), the annual dues are \$100.00.**

Associate Members, including individuals, corporations and other associations, which do not qualify as Regular BID Members may serve as Associate Members of the Mission Hills BID, either directly or through the delegate they assign, in one of the following ways: **Voting Associate Members** or **Non-Voting Associate Members** as outlined in the Associate Member Application (a) and (b) of this form.

- (a) **Voting Associate Members.** Any owner (or a Delegate of any owner) of a business, which is located within the boundaries of the Mission Hills BID, but which does not pay business improvement district charges assessed by the City of San Diego, may apply to become a Voting Associate Member of the BID. Voting Associate Members shall have paid \$100.00 in annual dues. All Voting Associate Members shall have the right to vote on all matters requiring a vote of the membership of the BID under the law, Article of Incorporation, or these Bylaws, and are eligible to serve as a Director and Officer of the BID;

or

- (b) **Non-Voting Associate Members.** Any owner (including corporations and other associations) who operate a business, or wish to associate with the BID as an individual (regardless of their location or where they reside) because they are interested in supporting the Mission Hills business community through the BID and its activities, may apply to become a Non-Voting Associate Member of the BID. Non-Voting Associate Members shall pay \$100.00 in annual dues. Non-Voting Associate Members shall not have the right to vote on any matter requiring a vote of the membership of the BID under law, Articles of Incorporation, or these Bylaws, shall not be eligible to serve as a Director or Officer of the BID, and shall not be construed in any way to be part of the term “membership” as used in these Bylaws.

This application process is designed to be simple and easy for busy business owners.
